



Role of public libraries in promoting information literacy in Sri Lankan context

The ever-growing technological development leads to the proliferation of information exponentially and thus make information overload. Along with the information overload skepticism on validity, the information's reliability and authenticity have also been growing. Thus, there is a need for society to develop a strategy to combat these challenges. The strategy that the intellectual has already created is "Information Literacy" (IL). The term information literacy was first used by Paul Zurkowski in 1974, who stated the need for people to become "information literate" if they could survive and compete in an emerging Information Society. In 1989, the American Library Association defined information literacy as the "ability to recognize when information is needed and to locate, evaluate and effectively use and communicate information in its various formats". The IL is now considered as one of the fundamental humans right in the digital world and core skill for lifelong learning. The American Association of College and Research Libraries (ACRL) standard indicate following six competencies that an information literate person should be developed.

- 1. Determine the extent of information needed
- 2. Access the needed information effectively and efficiently
- 3. Evaluate the information and its sources critically
- 4. Incorporate selected information into one's knowledge base
- 5. Use information effectively to accomplish a specific purpose
- 6. Understand the economic, legal, and social issues surrounding the use of information and access and use information ethically and legally.

The concept of IL came to light in Sri Lankan comparatively recently. IL training has been introduced in some universities as a module which is taught mainly through university librarians. Although extensive training programmes had been conducted for teacher librarians and school library staff, its implementation in secondary schools is still questionable as it is not mandated in the school system. Therefore, the next major stakeholder to introduce the IL to the society is the public libraries, as the public libraries are considered the knowledge hub of society. Public libraries and serve the citizens irrespective of the caste, religion, age, gender, language and education.

The first question regarding IL's introduction in the public library is 'Can the public library contribute to IL training?' The answer is yes. The UNESCO Public Library declaration defines the functions of the public libraries in relation to Information literacy as follows:

- 1. Supporting both individual and self-conducted education as well as formal education at all levels;
- 2. Providing opportunities for personal creative development;
- 3. Ensuring access for citizens to all sorts of community information;
- 4. Facilitating the development of information and computer literacy skills;
- 5. Supporting and participating in literacy activities and programmes for all age groups, and initiating such activities if necessary

This indicates that the public library should incorporate IL training into its functions. Information literacy is a set of lifelong learning skills, and public libraries are lifelong learning centers of society. When these two systems are fused, they form the information society by increasing the competency among people. Moreover, the public library has strength over other libraries in promoting information literacy among society. One of the strengths is that the public library is traditionally recognized as a learning center, so the users trust it. If the public library is successful in IL training, it can train all types of users, unlike the university library and the school library. Another strength is that the public library can have lifelong contact with users and this gives long standing relationship between librarian and users.

The second question is, how can the public library contribute to IL? There are a wide range of IL programmes worldwide in public libraries. However, all of them are not applicable in Sri Lankan context. Hence, information literacy programme which suit Sri Lankan public library system should be developed. Since the public library has an image of a traditional information center, it is challenging to project a new image suddenly as a community training center. This transformation has to come gradually. This transformation's best starting point is to provide the community with enough ICT infrastructures within the library with internet access. The library will be used as an internet access place, and this attracts users. With this initiation, the library can start training programmes on ICT for various users like children, school students, retired people, and older peoples. The library can use social media to connect with people, advertise their training programme, and issue printed notices to the library's area. The library can also start training on the internet searching, use of the application in smartphones; introduce the e-books and e-newspapers portals and conduct sessions on the safe use of social media etc.

The public library can initiate a partnership programme with schools to develop IL competencies among school students. The library can invite nearby schools to use their ICT facilities at least once a month. Even though ICT is a subject in school curricula, many schools do not even have a single computer. The ICT facilities of the library will help these types of schools. During the students' visit, the library can organize a short IL training programme for students. Another opportunity for the Continued in page 3 public library is the reading month celebration.

The information literacy programmes can also be incorporated in the reading month celebration, targeting the schools' students and general users. It is obvious that the public library cannot train the users in all the spectrum of information literacy. Nevertheless, the idea presented here can give the users fundamental information skills of IL.

The third question is: What are the limits or barriers of the public library to implement IL programmes? It is necessary to discuss about the limitations, so that the actions can be taken to rectify the barriers. The leading two barriers are the lack of ICT facilities for many public libraries and lack of IL training/skills for librarians. Apart from this, the reluctance of librarians to change from the traditional role, poor public perceptions about public library's function, and lack of positive attitude also contribute to barriers in implementing IL programmes in the public library.

The local government bodies that constitute the public library have a significant role in facilitating and motivating the libraries to engage in these kinds of programmes. The librarians also need to develop their skills on par with the current trend, and plan and implement innovative service programmes in public libraries.


ANNUAL RESEARCH SYMPOSIUM OF NILIS -2021
